The Pacific Northwest Chapter is excited to offer our members a **FREE** 4 hour Fire Safety training course. This will be presented by ReMA Ryan Nolte, Director of Safety Outreach and Kenneth Kunze, President of IC Fire Prevention. This course will help recyclers to better understand the following:

- Emergency action procedures
- Fire extinguisher usage
- Ignition and fuel sources
- The importance of inbound source control
- Relationship building with the local fire department
- Fire protection systems
- General housekeeping and storage

Standard chapter meeting will follow training in the evening. Cocktails and dinner will be provided. Speakers will be ReMA Safety Staff - Ryan Nolte, Director of Safety Outreach and Kenn Kunze - President of IC Fire Prevention They will present on general safety offerings and how they can help create a safer work environment. We will also hear John Sacco, President and Co-Owner of Sierra International Machinery and host of Repurposed and Pile of Scrap podcast will talk about the recent name change of ISRI to ReMA.

ReMA Blueprint – Safety Culture Assessment – ReMA staff will tour your facility and make suggestions on possible facility improvements. Approximate time 3-4 hours.

Power Industrial Vehicle - Forklift - Train the Trainer - This course will cover forklifts, skidsteers, and wheel loaders, or any combination of these three that you may have at your facility. Approximate time 4-6 hours.

Material Handler Train the Trainer - This covers the Safe operation of Material handlers and safety around the equipment including pre trip and post trip inspection. This does not teach how to operate a Material handler. Approximate time 4-6 hours.
