## **Operational Roles**

# Recycling Technician

-Description: Responsible for the collection, sorting, and processing of recyclable materials. This role involves operating machinery, monitoring equipment for malfunctions, maintaining cleanliness, and assisting with general facility operations to ensure efficiency and safety.

# **Logistics Coordinator**

- -Description: Assists in managing the coordination of transporting recyclable materials from collection points to processing facilities. This role involves route planning, scheduling deliveries, and coordinating with drivers and facility managers.

    freight rates etc.), basic mathematics, logistics management software, basic supply chain
